

Assistant Director of Finance (M/F/D)

The Finance Department is responsible for all accounting, controlling, liquidity management, tax, and procurement activities and interacts closely with the operating departments.

The Assistant Director of Finance is a newly created position within MLM Medical Labs GmbH (the Company) and will report directly to the Director of Finance.

It is assumed the Assistant Director of Finance will be the leading candidate to replace the current Director of Finance upon her retirement in approximately 18 to 24 months.

During this period, the Assistant Director of Finance will initially focus on implementing a best-inclass financial planning and analysis function while simultaneously learning the business and transitioning various responsibilities from the Director of Finance.

In performing this function, the Assistant Director of Finance will be an integral member of the MLM Medical Labs GmbH Leadership Team.

Responsibilities:

- Perform financial modeling, build, create and modify revenue, labor, and other financial models in cooperation with the Finance Director, Global CFO, and departmental leaders within the site.
- Work with departmental leaders to periodically forecast the near-term P&L and provide feedback on the accuracy of forecasts; provide recommendations to enhance the effectiveness and efficiency of the process as well as business operations.
- Analyze and interpret large amounts of operational and financial data, converting it into meaningful and focused information and reports which drive performance results and actions.
- Oversee the preparation of the monthly reporting package (including financial results and operational metrics/KPI's) and provide meaningful insights into the business, including identifying trends and drivers of business performance.
- Lead the development of the annual operating budget; present to the senior & global executive teams.
- Assist with the overall achievement of the site's financial targets.
- Partner deeply with the business to provide insights and influence the decision-making process.
- Strive to continuously improve the efficiency and effectiveness of the financial reporting and data analytical support of the business.
- Lead and/or participate in special projects and assignments as required.
- Make recommendations to management based on analysis of data and implement new protocols, methodologies, and processes.
- In the absence of the Director of Finance, assume her responsibilities.
- Support the Director of Finance to develop a best-in-class finance team.

Education and experience:

- Bachelor's degree in Finance or Accounting required; Master's degree or MBA (or equivalent) preferred
 - Certifications are a plus.
- Minimum of eight (8) years of experience with progressive financial responsibility and accountability in accounting and financial planning and analysis.
 - Experience in the life-sciences (and/or CRO) industry is a plus.

- Advanced Excel skills, including pivot tables, cell formatting, data filters, data sorting, chart and formulas/functions.
