

# Terms and Conditions - Where were you in 1993 campaign

# 1. Promoter and Participants

- 1.1 The Promoter is MLM Medical Labs GmbH and its affiliates, registered at Dohrweg 63, 41066 Mönchengladbach Germany. ("MLM")
- 1.2 There is no country-specific limitation to all entrants ("Participants"). Entries are accepted from all over the world. All participants have to be aged 18 and over at the time of the competition entry. The winner may be required to submit proof of age.
- 1.3 Employees of MLM Medical Labs GmbH its affiliate and subsidiary companies and their families are not eligible to enter.
- 1.4 By entering this Competition, all Participants are deemed to have agreed to be bound by these terms and conditions unless notified otherwise in writing

## 2. The Competition

## 3. How to participate

- 3.3 Incomplete, invalid or inappropriate entries, or entries received after the closing date 1st December 2023 will not be eligible for any prize;
- 3.4 All entries must be received during the Competition Period described above. Any submissions received outside of the Competition Period will not be accepted for entry to the Competition.

  - 4.1.4 content that is offensive or could affect negatively on the name, reputation or goodwill of MLM
  - 4.1.5 defames, misrepresents or insults other people or companies, including, but not limited to MLM and its affiliates or promotes any political agenda.

- it shall act within the scope of the rights granted under these terms and conditions
- personal data will not be disclosed to any other party.
